As you are aware businesses in the West of Hudson Watershed that sustained Structural Damage, Equipment Loss, Property Loss and Inventory Loss as a result of flooding from Tropical Storms Irene and Lee may receive assistance from a program approved by the Board of Directors of the Catskill Watershed Corporation (CWC).

Please be advised that in order to start this process the following steps need to be completed:

1. Please provide separate estimates for Structural Damage, Equipment Loss, Property Loss and Inventory Loss. These estimates must be performed by a Private Contractor. Please note that the contractor's name, address and telephone number must be indicated on the estimates. Also, please indicate on attached form the estimated amount for each loss. Please write legibly.
2. On the attached form please indicate your Insurance Carrier, address, broker's name and telephone number. Also, please attach any claim filed, whether it was denied or accepted. Please indicate if there was a deductible and the dollar amount.
3. Indicate if you have requested or received any commitment of financial support from any other agencies (FEMA, Phoenicia Rotary/Sharp Committee, Timberlake Camp Relief Fund, etc.).

Once these steps have been completed please submit all documentation to:
