1.01 RELATED DOCUMENTS:

A. Drawings and general provisions of Contract, including General and Supplementary Conditions and Division 1 Specification Sections, apply to work of this section.

1.02 PROJECT/WORK IDENTIFICATION:

Do not unreasonably encumber the site with materials or equipment. Confine stockpiling of materials and location of storage sheds to the areas indicated. If additional storage is necessary, obtain and pay for such storage off-site.

Lock automotive type vehicles such as passenger cars and trucks and other types of mechanized and motorized construction equipment, when parked and unattended, so as to prevent unauthorized use. Do not leave such vehicles or equipment unattended with the motor running or the ignition key in place.

1.05 ITEMS PROVIDED BY THE OWNER:

A. The Owner shall provide basic survey data, including bench marks and reference points only. The Contractor shall provide all lines and grades required for construction.

1.06 PROJECT LIMITS:

A. The project limits on private properties shall be within the temporary construction easement boundary for the proposed structures. The Contractor shall contain all of his equipment and materials within these bounds unless he makes private arrangements for the use of other lands.

1.07 DIVISION OF WORK:

A. The Contract for General Construction will include all work called for on Sheets 1 through of the Drawings and these Specifications.
