

Upcoming Town Board Topics & Activity MONTH OF APRIL 2019

SHANDAKEN SEPTIC DISTRICT: This past Saturday, March 30th residents in the

Hamlet of Shandaken whose properties are located in a proposed Septic Maintenance District were asked to vote on the formation of said District. We are happy to report that by an overwhelming margin the approval of the District passed with all votes cast and counted with a final tally of 26 in favor and 1 against. We await the next steps for the formation of the District which will include the adoption of the “Sewer Use Law” for that District and the repairs and replacement of nearly half of the septic systems within the District occurring this summer and fall. Later this year the remaining funds will be turned over to the Town for future maintenance and repairs. The formation of this District will be helpful in quickly resolving issues with any future repairs or replacements as they become necessary. The hope is that the funding being provided should be able to self-sustain the District for generations to come.

PHOENICIA WATER:

We just held a public hearing as required in order for the Town to again apply for Community Development Block Grant funding for work in the Phoenicia Water District. Again we will be applying for the maximum allowed of \$750,000 for work on the High Street Loop, a Third Finishing Pump for the filtration plant, chemical storage and ventilation and video inspection of the water tower. After speaking with officials with the Office of Community Renewal, it seems feasible that we could be awarded these funds with a few tweaks to our previous application. Additionally, the Town has a need for looking at one or more grants to assist us with some necessary Planning Activities. Of utmost need is a grant to study the traffic and parking situations in Pine Hill and Phoenicia. Specifically, we need to do this for Pine Hill in order to move forward with an ongoing Stormwater Retrofit Project with the CWC. There may be other possibilities that come forward so we are just trying to cover all bases for any application saving us having to redo these required resolutions.

HIGHWAY:

The Town Highway Trucks are aging and need to be replaced. The Highway Superintendent, Eric Hofmeister, has identified two plow trucks that are in desperate need of replacement this year. Conveniently, an opportunity has become available through State Bid to acquire these vehicles before the next plowing season. The two vehicles will cost on average \$195,000 each (including plows and wings). We have funds currently available in the budget to supply \$120,000 for these purchases. We will then be financing the remaining \$280,000 through Key Governmental Financing for the next 7 years for annual payments of roughly \$45,000, which will be budgeted. We feel this is necessary and feasible and helps minimize the immediate impacts on the taxpayers.

Additionally, Eric and his crew have occasionally had disputes with certain property owners regarding the Town’s road dimensions and right-of-ways. We would like to hire a surveyor to assist the Highway Department in better

defining the areas in question so as to resolve some of these disputes moving forward. We will award the work at next month’s regular Town Board meeting.

AMBULANCE:

We have a resolution to promote two employees. Therese Surak will be returning as a F/T EMT at \$12.10 per hour, a position she previously held with us. We would also like to congratulate Robert Lovaglio-Emry for his completion of certification as an Emergency Medical Technician. He will be promoted from P/T Driver to P/T EMT and will be paid at his new rate of \$12.10 per hour.

MISC:

We have a resolution for Waiver for a Liquor License for a new business opening in Pine Hill NAMED Pine Hill Mercantile. We look forward to this new addition to Main Street opening its doors and we wish the owners the best of luck and success in this new venture.

PARKINSON’S MONTH:

Again we join in marking April as Parkinson’s Awareness Month and have a resolution showing our support for finding a cure. Parkinson’s Disease is not only debilitating to the individual diagnosed with it, but bears a burden on the family and friends who witness its effects on the patient. Please take a moment during the month of April and reach out to a multitude of organizations who are working hard to find a cure for this terrible disease.

Granted there is much more work to be done, but it’s a good start!

Speaking of Mr. Lovaglio- congratulations to him upon obtaining his NYS Emergency Medical Technician (EMT) certification! The EMT curriculum in NYS is comprised of over 200 hours of didactic, laboratory, clinical, and field instruction spanning a timeframe of 3-6 months- a herculean feat considering most (including Bobby) must balance a full-time job, responsibilities at home, and emergency services affiliations during the time of instruction. Again, congrats to you Bobby- and thank you for your service.

I would be remiss if I were to neglect to remind everyone that aside from being April Fool’s day, we also observe a major holiday for many (including myself) here in the Catskills- opening day of Trout Season. As many of us take to the water in our usual ritualistic manner be sure to take care where you step, and ALWAYS wear a wading belt if wearing waders on the water. WHEREAS, the Town of Shandaken owns and operates a municipal water system located in the Hamlet of Phenicia (Phoenicia Water District); and

WHEREAS, Community Development Block Grants (CDBG) funds are available for such infrastructure improvement and planning activities through the New York State Consolidated Funding Application (CFA) process;

THEREFORE BE IT RESOLVED that the Town of Shandaken Town Board does hereby authorize the Town Supervisor to apply for up to the maximum amount of \$750,000 from CDBG through the CFA process for said infrastructure improvements for the Phoenicia Water District; and

Project Description and Preliminary Scope of Work

The Town of Shandaken is soliciting proposals from qualified firms for assistance in the following:

Project Description

Assist the Town of Shandaken Highway Department in surveying portions of Town Roads and Right-of Ways.

Completion Date

Project has a proposed completion date of September 30, 2019.

Scope of Work

Professional services required are likely to include:

- Surveying and identifying boundaries of certain Town-Owned roads and operational areas.
- Surveying and identifying Deeded Right-of-Ways for Town maintained roads and operational areas.
- Surveying and identifying Right-of-Ways By Use for Town Maintained roads and operational areas.
- Provide detailed and stamped maps for areas designated by the Town Highway Superintendent.
- Other survey work as designated by the Highway Superintendent.

Other: 1) The successful firm or individuals **must** have familiarity with Highway law and usage regulations.

Submittal Content

The proposal must be organized in sections containing the following information:

- **Description of Firm.** Describe your firm's legal structure, areas of expertise, length of time in business, number of employees, and other information that would help to characterize the firm. Provide the address of the main office (for legal purposes) and the address of the office that will manage the project.
- **Experience.** Briefly describe other projects executed by your firm that demonstrate relevant experience; however, extensive descriptions of vaguely related projects are discouraged. Also list all public sector clients for whom you have performed similar work in the past five years. Please highlight projects illustrating work within the Catskill Forest Preserve and the New York City West-of Hudson Watershed. For each project mentioned, include the name, address and phone number of a person who can be contacted regarding your performance on the project. When submitting projects for which your firm worked in an auxiliary capacity or in a joint venture or partnership, include the name and address of the lead firm as well as the name and addresses of the other firms with which you worked.
- **Personnel.** Provide a professional resume for the key people proposed to be assigned to the project (including any important sub-consultants), and describe relevant related experience. Describe key personnel's proposed roles and responsibilities on this project. Submittals must identify a proposed project manager, who would be responsible for the day-to-day management of project tasks and would be the primary point of contact with your firm. An organization chart of the project team may be appropriate but not required.
- **Costs.** Provide a schedule of the hourly rate of each person who would be working on this project and set forth a detailed description of any other costs, disbursements and expenses that would be charged to the town by the firm.
- **Project Approach.** Describe the tasks that must be accomplished to complete the project. Provide a narrative description of how the firm proposes to execute the tasks. If applicable, discuss any unique aspects of the project, alternate approaches the Town of Shandaken might wish to consider, or special considerations related to programmatic/ funding requirements. Your firm should rely on its expertise and experience with similar projects to demonstrate how it will effectively complete the project.
- **Project Schedule.** Provide a schedule of past general projects and activities indicating the duration of each activity and of the total project, including a schedule of Personnel assigned to project. Submittal Deadline

Four copies of the proposal must be received no later than 12:00 p.m. on Monday, April 29, 2019 at the Town Clerk's Office, Town of Shandaken, 7209 Rte. 28, P.O. Box 67, Shandaken, NY 12480. Proposals must be clearly marked with large block lettering on the envelope "**Survey Bid.**" Proposals received after the deadline will not be considered.

Selection Process

Proposals will be ranked based on the factors set forth below and the Town of Shandaken Review Committee and Town Board, in its discretion, may choose to interview several of the top ranked firms or it may reject all of the applicants. However, at its discretion, the Town of Shandaken may dispense with interviews and select a firm to perform the work. Firms will be evaluated on the basis of the following factors:

- Firm History and Capability to Perform Project
- Relevant Project Experience
- Qualifications of Project Team
- Familiarity with Area and Project
