

# Upcoming Town Board Topics & Activity MONTH OF AUGUST 2020

**COVID-19:** We have slowly been working toward re-opening of Town Hall. As of tonight, Town Hall offices are back open with protective measures in place following CDC guidelines to protect our staff and the public. We still would request that if you need to visit the office, do your best to schedule an appointment with then appropriate department. Masks will be required and we have hand sanitizer stations. Regarding public meetings, public are invited to attend Town Board meetings while maintaining distance and wearing masks. We will limit access to the back half of the room, while officials are invited to stay toward the front of the room in order to present information. Regarding Planning and Zoning Board meetings, we have recommended that specific applications will be given a scheduled time slot and anyone with interest in a particular application may attend but again we ask that you do your best to utilize the TV broadcast, You Tube Channel postings and in the case of Public hearings do your best to write an email or letter to the respective Board.

and things have been working out well so far. The kids enjoyed the outing to the National Baseball Hall of Fame and Cooperstown last week. Sadly, it is not looking good for Great Escape to be open for our proposed trip next week. We are instead looking to change that trip to simply a visit to Lake George Village where the kids and chaperones would be free to visit the Million Dollar Beach, the Steamboats, Fort William Henry or simply walk around the village. We wish we could find something more but we are still trying to do our best to provide protections while providing them an outlet before school starts in whatever capacity it may be.

**RESOLUTIONS:** We have resolutions to appoint members to the Planning Board and Zoning Board of Appeals. Both Boards need to be made whole and especially the ZBA, which following the loss of Keith Johnson, was down to three members out of five. These folks were the only applicants months ago and as we start to get back to public business, we need all available personnel.

Deputy Supervisor Van Blacum and I toured the Town Parks last week and started marking out locations for some playground equipment we have in storage, so we hope to install these items shortly. It has also been noted that many of the Park picnic benches have fallen into disrepair or have literally disintegrated. We are seeking bids for 10 8-foot long all-weather picnic tables to place around at different parks. POLICE & JUSTICE: NY State is requiring that each municipality with a Police Department create a committee to review our Police & Justice Court policies and procedures in order to allow us to apply for future grant opportunities, which we do regularly. We will be looking for a few residents to take part in this committee and report back any findings or issues that they feel need to be addressed or revised. Police Chief Storey will provide more during his Departmental Report.

**SHANDAKEN DAY:** Sadly, we will have to cancel Shandaken Day this year as with the current situation we don't see a way to host the event and maintain CDC and State Guidelines comfortably. This does not mean we are discontinuing the event, only postponed for this year.

# **July Ambulance Update**

The past Five months have been the most difficult time to be a first responder in the history of what we do. It's not necessarily even mitigating the calls – after all, the balance of the calls the Ambulance has been handling (with very few exceptions up until late) have been general illness and medical calls- at a lower volume.

It's more so the emotional and psychological toll that all first responders worldwide have been dealing with- to the point that when Ulster County 911 advises units during their dispatch that "respiratory precautions are advised" (a code for a patient meeting COVID-19 criteria), you cannot be sure if this call will be the one that brings a deadly virus back to your loved ones. Some of our employees have not seen their particularly at risk loved ones just because of that, and some have been lost during that time as well.

Our lives as First Responders, and all healthcare in general have changed forever, and we must take great care to assure the continuity of our services for those that count on us the most.

Remarkably, the Town of Shandaken Ambulance has had zero employees contract the virus, and only a handful that needed quarantine secondary to exposure despite treating COVID positive patients. Much of this can be attributed to early training and continuing education regarding the virus, and proper personal protective equipment - which can be attributed to our Equipment Manager, the Ulster County Department of Emergency Services, and continued support from the Town. We have been incredibly lucky.

Despite our luck it is our duty to continually assure safety for all employees, and citizens alike. As many of our employees, including our Chief officers, work elsewhere in emergency services aside from the Town of Shandaken we have enacted extremely strict criteria for public interaction and social distancing while on and off the job. One of those criteria is that employees are to avoid large groups whenever possible – hence why we have not been attending Town Board meetings the way you may have been used to. Please be assured that this is more for the safety
