With the busy Winter season now behind us, the Ambulance Service has found time to catch our breath, and catch up on some training and much needed housekeeping. Payroll orientations, credential recertifications, equipment checks and upkeep, and facilities maintenance take up the balance of time when our responders aren't out helping those in need. One thing is for certain though; the operation has outgrown our current infrastructure. The Town Ambulance is the only 24/7 staffed Municipal service within the Town of Shandaken. The sheer size of ambulances alone (and believe me, we don't buy big fancy ambulances) have increased to the point that our vehicle housed out of the Route 42 municipal building cannot fit into the Fire Department owned and Town rented bay in the Village of Phoenicia. That's right; we pay monthly rent To the Fire District for a garage that is too small for our operation and is landlocked during floods.

The aforementioned doesn't even scratch the surface of the issues with our buildings. The staff housing building (medic building) located adjacent to the medical arts building on Ava Maria Dr. is extremely small, landlocked during flooding, and at most times is occupied by three individuals 24/7. The approx. 400 square foot building provides a double occupancy bunkroom, a single occupancy bunkroom, kitchenette, common area, and one common bathroom which must be used by all employees- which doubles as our decontamination area following calls involving bloodborne pathogens, and most recently, deadly pandemics. Every time an employee needs to decontaminate following a call, they must walk through the main common area of the building- potentially exposing other crewmembers to pathogens. It is the only area the Ambulance employees can use for these purposes. It's a miracle we didn't have more COVID cases amongst Ambulance employees at the height of the pandemic. In addition, staff must go outside and continually clean snow off of the \$65,000 Paramedic car as there are no garage facilities at the staff housing, and Ambulance Technicians must drive their personal vehicles to the ambulance bays.

Yet another major challenge is that both the Ambulance and Police share the building on Route 42. The Police Department should be a secure and independent facility. There is no reason why a Police officer should have to walk someone incarcerated around an ambulance smack dab in the middle of their facility stocked with narcotics, and conversely the Police Department should not have to worry about Ambulance employees opening bay doors during the course of an interview, investigation, or while detaining an individual. Additionally, the existing office and storage space is not adequate for the Ambulance Service.

While these issues only scratch the surface of our equipment and housing woes, the solution would be one dedicated Ambulance building with adequate indoor space for all equipment, staff, and storage. Fortunately, there seems to be great interest in potentially funding this project, and at little to no cost to taxpayers through grant funding. This would not only solve issues for the Ambulance service, alleviate rental payments, and alleviate longstanding logistical issues for the Police Department; it would allow our responders a safe and secure quarters from which to work from. Stay tuned.. and support your local Ambulance Service!

Dear Trustees,

The Shandaken Town Board has been following the district's long-range planning and public conversations around potentially closing one or more of our local schools. Schools are, of course, true anchor institutions for a community and the closing of any facility can and will have an obvious impact on a town and its residents.

We both acknowledge and appreciate the challenges the District and the Board of Education face with a shrinking student body. As a town, we have faced similar challenges – a smaller and aging workforce, fewer full-time residents, and a diminished pool of volunteers.

We are, however, greatly encouraged by the recent influx of residents over the last several years. Many of these families are new arrivals; others had been part-time residents who now reside here permanently. COVID was, of course, largely the impetus for this move, but the greatly expanded capacity for many individuals to work remotely is now allowing people to consider living in our area permanently who never could before.

It goes without saying that many of these new arrivals have children or intend to. In some cases, it's why they moved here.

As you surely know, Phoenicia Elementary is at the heart of our community. It is the starting point for our parades. It is where our children safely Trunk-Or-Treat. It is home to our community garden and where clothing swaps take place and cake walks and barn dances happen. A centralized campus may have financial benefits and be easier to administer, but if we lose the sense of community that makes people fall in love with our town, we can only expect student enrollments to decline further.

As a town, we applaud the efforts the School District has taken to involve the community as much as possible. We hope those efforts continue, and that all consideration will be given to the role these schools play in shaping not just their students but the places those students live both now and into the future.
