# SUPERVISOR'S NOTES - APRIL 2023

This month we are working on grants towards our Conservation Advisory Councils food scrap collections program joined with our recycling and looking for grants for our Comprehensive Plan Update committee.

Tonight, we will have a budget presentation by Onteora Central Schools Superintendent Victoria McLaren and Assistant Superintendent for Business Monica LaClair.

We received about 120,000. granted from AWSMP for the Pine Hill LFA We are applying for another 6,500. added to that for engineering on a bridge on Bonnieview. This summer the Town will be replacing that Bridge and Ulster County will be replacing the other above it.

Later this month, with another Grant from partners of Ashokan Watershed Stream Management Program. they will send Donna Lamoine, our Code enforcement officer, Kevin, Eric and myself to Syracuse for a flood management seminar.

- 1) Motion to; take bids for a Septic Pumping company to pump and dispose septage for 53 septic tanks in the Shandaken Septic Maintenance District, approximately 1000. gallons each. Bids need to be received in the Clerk's office by April 30 and will be awarded at the May 1<sup>st</sup> Town Board meeting. We reserve the right to refuse any bids.
- 2) Motion to; Request for qualifications (RFQ) and/or request for Proposal (RFP) for a Planner or Planning firm to assist with the Town of Shandaken Comprehensive Plan Update Committee. Bids need to be in the Clerk's office by April 30. We reserve the right to refuse any bids.
- 3) Motion to; A bid for busing service for Shandaken Summer Recreation Camp. Six-week program, generally three times per week possible. Start pick-up 8:30 am in Mt. Tremper and pick up in four locations on Route 28 and delivery to the Pine Hill Lake. Return at 4:00 pm. We reserve the right to refuse any bids.
- 4) To reduce foods in the waste stream, Motion for our Conservation Advisory Council (CAC) to research and apply for a grant to develop a food scrap recycling program. Operational days and times the Town recycling center is open.
- 5) Motion to: receive bids to sand and refinish meeting room hall floor of @1100. s/f

#### March 2023 Report

In a landmark moment in the history of the Town's Ambulance Service, the Olympic Regional Development Authority (ORDA) has finally agreed to supplement the costs of providing responses to Belleayre Mountain. For many of the Town's "old timers", you may remember that this has been an ongoing conversation for decades, however never truly gained momentum despite the best efforts of both Ambulance and Town personnel. The Ambulance Service responded to Belleayre 66 times this season (from November 2022 to present), with 31 calls occurring in January 2023 alone.

Following research by Councilmember Drake and Ambulance Administration, it was found that yearly subsidies had historically been provided to all other Ambulance Services providing care to ORDA facilities falling within their operating territory. After discussions with the President of ORDA, it was indicated that starting in 2023 the organization shall contribute yearly to the Town of Shandaken Ambulance Service. Any contribution to defer costs to the taxpayer for the service that the Ambulance provides is a huge help, and this conversation has indicated a desire to talk further about how to make sure the Ambulance Service is best capable to accommodate growth both at the ski center, and for local needs.

Many thanks to the ORDA Board, as their decision to finally provide this long awaited subsidy will provide relief to the costs of providing the level of care expected at Belleayre by our responders. And lastly but certainly not least, this could not have been possible without the support of the Town Board- however specifically Councilmember Drake who resurrected the conversation, and followed up in an official capacity to assure that this landmark moment could occur. Many thanks, and onward and upward!

Samantha from the Ulster Savings bank asked me if I could interview Calvin Smith, he'd like to share Phoenicia history with us, I'm working on a good day for this. We also set up a display at the Ulster savings Bank as the Business of the Month.

Rafael Santiago from the Shandaken Inn came in for the tour. He wants to learn more Shandaken history for a special trivia night at the Clubhouse. Pamela Martin came in she has a poetry walk set up in Pine Hill. April is poetry month and the museum provided vintage pictures of the buildings along the poetry path as well as poems written in the early 1900's by Merryl Blish also of Pine Hill. Another project I'm working on is history display and booklet for the Big Indian\Oliverea Fire Department , they are celebrating 75 years of community service and their Ladies Auxiliary is active now for 70 years. #### **RESOLUTION Join the Ulster County Housing Smart Communities Initiative**

WHEREAS, the Town of Shandaken Town Board, believes that rising housing and rental costs and a lack of diverse housing opportunities for all community members pose a significant challenge to the members of our community; and

WHEREAS, affordable housing is defined as housing in which the occupant is paying no more than 30% of monthly or annual income for housing costs, including utilities; and

WHEREAS, ensuring there are affordable housing options for all community members is a key responsibility of the elected officials of the Town, and a critical component of creating a healthy, sustainable, and prosperous community; and

WHEREAS, rising housing and rental costs and a lack of diverse housing opportunities for all community members is in part due to the demand for housing far exceeding the supply of new affordable and workforce housing being developed in the community; and

WHEREAS, a long-term commitment by the Town to review and approve new affordable and workforce housing projects is a critical strategy for ensuring there are affordable housing options for all community members; and

WHEREAS, working toward housing solutions is a priority for the well-being of the local residents, the economy, and community sustainability; and

WHEREAS, we believe that our response to housing challenges provides us with an opportunity to improve housing opportunities and community wellbeing for all community members, and to build livable, affordable, and housing-smart communities,

IT IS HEREBY RESOLVED that Town of Shandaken, in order to meet local housing needs, adopts the following commitments as part of joining the Ulster County Housing Smart Communities Initiative. This commitment includes completing the following six steps:

- 1) Join the program through municipal resolution and begin engaging with the community
- 2) Designate a Housing Smart Community coordinator to serve as liaison between Ulster County and the municipality
- 3) Form a housing task force or designate an existing official housing-related body of the Town to serve as the group committed to the program
- 4) Register for participation in the program on the Housing Smart Communities Initiative website
- 5) Establish a community outreach and educational campaign on the importance of developing a range of housing options
- 6) Begin implementing a prioritized set of the Housing Smart Actions included in the program
