Upcoming Town Board Topics & Activity

Month OF 8/6/12

Phoenicia Sewer: The Town was notified by the Environmental Facilities
Corp oration last week concerning the funding for the proposed Phoenicia Sewer Project.
According to EFC the Town had until the end of business today to decide whether we mutually agreed to release the funds allocated for the project. If the Town chose to argue points of default on the contract with the city, there would be "consequent negative impacts" to the Town's financial status. It is still the Town's estimation that the City is at default on this agreement as they never provided the funds sufficient for an approvable project. The Town Board has unanimously agreed to agree to this "mutual default" so it would not have a negative impact on the Town. We consulted with the Town's Attorney on this and it seemed the most practical response for the Town. We will release a more formal statement after further conference with our attorney.

Recreation: We have several resolutions tonight. The first is hiring Gilmour Planning, LLC to assist the Parks and Rec Board in creating a Comprehensive Plan for the Parks. This is being paid from a grant received from the Hudson River Valley Greenway. Also we are supporting the Parks and Rec Board in requesting that the DEC's newly acquired 1200 acre parcel adjacent to Belleayre be designated as "Intensive Use," it is both board's feelings that it still provides "Forever Wild" protection but allows for a multitude of recreational uses which we all feel would be an economic boost to our Town and region. And last we have a resolution to Support the Catskill Divide Bike Race scheduled for August 19th.

SAFARI: We have several large stream stabilization projects slated for the Stony Clove and Warner Creeks. These projects are high on our priority list and being funded through the Natural Resources Conservation Service and coordinated through the Ulster County Soil and Water Conservation District. These jobs need to be awarded fairly quickly

because these are large jobs and they need to be completed prior to September 30th, the date we are supposed to cease all stream activity according to the DEC. We have scheduled a special meeting for the 20th of this month to award these projects. We also will be looking at new flood plain regulations as recommended by our Flood Mitigation consultants. These new regulations would help the Town accrue Community Rating System points helping to reduce overall flood insurance rates Town Wide. This first regulation will be amending the application providing more information on proposed development within floodplains, the second would be amending the Town Law regarding cumulative impacts to structures already within the floodplain. Essentially, any structure receiving 50% or more improvements to their structure cumulatively over a ten year span, must bring their entire structure up to current code. These regulations will provide a savings for all residents and further ensure the resiliency of structures in the flood plain areas. We do not have the specific language ready, as of this meeting, and if we do not have it ready by the middle of this month we will not hold a public hearing on the law as currently proposed in a resolution tonight and reschedule it for a later date.

Highway: Eric is looking to purchase a new dump truck for the Highway Department he has the budgeted monies available and can purchase it through the County Bid. We also have a resolution prohibiting hydro-fracking fluids from being used on Town roads. Although we currently do not use these fluids, the environmental damage to the Town would, in our estimation, be detrimental to the forest preserve that we live in and feel it is right for us to join others in prohibiting the use of these fluids on our roads.

Comptroller: The State Comptroller's office has been taking a tour of local Towns and in his stop here highlighted some policy and procedural changes that need to be updated. The most glaring was the Town's Procurement Policy which has not been updated since 1991. Under the current structure the Town is to receive verbal bids in excess of \$100 and written bids in excess of \$1000. The comptroller suggested that in order to make the offices more efficient we were advised to amended to, at the very least, the State minimum, which would increase these to \$1000 and \$3000 respectively. There are different levels for Supplies and Equipment versus Public Works Projects which garner higher levels as they tend to be more expensive projects. We will hold a public hearing on these amendments prior to our meeting on August 20th. The other suggestions were inter-office changes that we have already started implementing and will continue to address over the coming months.

Museum: Sadly, the Director hired at last month's meeting felt he would be unable to perform the duties and has handed in his resignation, we will be advertising the opening again for Museum Director.

Phoenicia Water: The water district has some cash on hand that can be used to address projects highlighted in the Preliminary Engineer's Report completed last year. Tonight we a sending out and RFP looking for a Construction Design Firm to draw up plans to complete what is commonly referred to as the "High Street Loop" connecting the waterline from the Woodland Valley Bridge to the end of the main along High Street. We will be awarding this job at our August 20th meeting to help ensure the district can get the job completed prior to cold weather setting in.

Shandaken Day: is getting ready to go in Pine Hill on August 25th. Sadly, due to logistical issues involving the transfer of management from DEC to ORDA, we will not be moving the event to Belleayre. We also will not be hosting fireworks. Although, we have had some recent rain, the dry weather could quickly return and we did not feel it right to hold fireworks while a statewide burn ban remains in effect. Those issues aside, we are looking forward to celebrating on Main Street from 10am until 6pm, with all of the usual fun and fanfare. We currently have only a few locations left, so please get your applications in ASAP. The flyer will be in the Freemen on August 16th. This year we are noting the fact that Pine Hill has been placed on the State registry of Historic Places, while awaiting the same from the National Registry. Doris Nieves will be holding a ZUMBA dance at the Community Center and we will have live entertainment all day. As usual we will be giving out all sorts of awards including a special awards ceremony recognizing people and organizations that were intrinsic to the recovery of the Town since last year's floods.

Smart Growth: The Town is glad to report that the Pavilion Repair in Glenbrook Park is complete. I'd like to thank Black Bear Builders of Margaretville for doing this job quickly and working with the Town by clearing out equipment every weekend, so we could still rent the pavilion. They placed stone faced columns to the bottom of the pavilion to enhance the look and provide protection from further rot, which was a severe on some of the posts. This job cost the Town nothing as all funds were provided through the Smart Growth Grant program. Additionally, Kurt has completed the Rte. 28 signs and the sign for opposite the Eagle entering Phoenicia. Eric and I need to coordinate the time to install these signs, hopefully this month. The work provided by our

Highway crews will apply as our match for this grant. Lastly, the kiosk committee has been meeting and we are anticipating seeing some drafts of panels coming up shortly.

I'd like to thank the organizers of the Festival of the Voice which was well received in Phoenicia this past weekend. Business owners throughout the Town seemed pleased with the turnout and we certainly look forward to this event continuing and providing a much needed lift for our local economy while highlighting the arts in our community.

Our next regular meeting is scheduled for Monday, September 10, 2012 at 7pm.

RESOLUTION CONCERNING DEC CLASSIFICATION OF THEIR NEWLY AQUIRED PARCEL ADJACENT TO BELLEAYRE MOUNTIAN

WHEREAS, the New York State Department of Environmental Conservation (DEC) has acquired a 1200 acre parcel of land adjacent to Belleayre Mountain along Rte. 28 in the Hamlet of Big Indian; and

WHEREAS, the DEC is asking for comments on the classification of this parcel; and

WHEREAS, the Town of Shandaken Parks and Recreation Board on Monday, July 30, 2012 unanimously supported a resolution requesting this parcel be classified as "Intensive Use," partly due to the new parcel being adjacent to Belleayre Mountain Ski Center and the Belleayre Beach (Pine Hill Lake), which are both classified as "Intensive Use;" and

WHEREAS, the land would still be part of the Forever Wild distinction within the Catskill Forest Preserve and would like to see more recreational activity allowed on these lands than allowed under other classifications; and

WHEREAS, The Town of Shandaken is limited in its development opportunities to improve economy and recognizes that expansion of recreational uses are essential to the economy of the Town in which near 85% of the land is publicly owned; and

WHEREAS, the parcel has a relatively flat ridge line and existing road networks that have been built and maintained which the Town believes would be an asset in providing a relatively accessible and minimal physically challenging area for use by the broadest base of individuals and families from the State of New York, as well as visitors from abroad and Town residents which would assist in the further development of the Town, and therefore the State's economy.

THEREFORE BE IT RESOLVED, that the Town of Shandaken Town Board supports the recommendation of the Town of Shandaken Parks and Recreation Board in urging that the entire acquisition be classified as "Intensive Use." This conforms to the classification assigned to Belleayre Ski Center and the Belleayre Beach, and is appropriate because the land is, in fact, an extension of Belleayre Mountain. The 1200 acres will become part of the NYS Forest Preserve guaranteeing that this land will be protected while allowing for activities such as Mountain Biking, Cross-Country Skiing and proper trail maintenance for these activities.

BE IT FURTHER RESOLVED, that the Town Board of Shandaken hereby requests that such parcel be properly named as the "Belleayre Ridge" so as to avoid any confusion as its physical location.

RESOLUTION PROHIBITING USE OF HYDRAULIC FRACTURING BRINE AS DE-ICING AGENT ON TOWN ROADS

WHEREAS, hydraulic fracturing (fracking) for natural gas involves the use of chemicals and hazardous materials during construction, drilling, hydraulic fracturing, gas production and delivery; and

WHEREAS, many of the chemical constituents injected during hydraulic fracturing have documented adverse health effect and/or adverse environmental impacts; and

WHEREAS, wastewater from fracking can contain radioactive elements

THEREFORE BE IT RESOLVED, as follows:

1. That the Town Board of the Town of Shandaken hereby resolves that brine from natural gas drilling, being production brine, produced waters, flow back fluids or hydraulic fracturing fluids generated as a result of

drilling for or seeking gas in wells, included but not limited to hydraulic fracturing, shall not be used as a deicing agent on the roads of the Town of Shandaken; and

2. That this resolution shall take effect immediately.

A LOCAL LAW TO AMEND ARTICLE 41 OF THE TOWN CODE OF THE TOWN OF SHANDAKEN

BE IT ENACTED by the Town Board of the Town of Shandaken as follows: **SECTION 41-2 – Determination of whether procurements subject to bidding A. Procedure**

- (1) Purchase contract for supplies and/or equipment in excess of twenty thousand dollars.
 - (2) Contract for public works in excess of thirty-five thousand dollars.

SECTION 41-5 – Adequate documentation

Documentation of actions taken in connection with each such method of procurement is required as follows:

A. For contracts involving supplies or equipment in excess of three thousand dollars but less than twenty thousand dollars and for contracts for public works in excess of ten thousand dollars but less than thirty five thousand dollars there shall be a written specification request and written quotes from three vendors.

- B. For contracts for public works in excess of three thousand dollars but less than ten thousand dollars there shall be an oral or written specification request and written quotes from two vendors.
 - C. For contracts for supplies and equipment and for contracts for public works in excess of one thousand dollars but less than three thousand dollars there shall be an oral specification request and oral or written quotes from two vendors.
- D. For contracts for supplies and equipment and contracts for public works less than one thousand dollars the contract may be awarded at the discretion of the entity making the purchase.
- E. All quotes are to be documented in writing by the Department head or the designee making the request.
- F. If Department head or designee have a failure in meeting guidelines set forth above then Department head or designee are required to document in writing reasons for failure in process. (i.e., low reply rate, etc.)

SECTION 41-7 – Items excepted from policy and procedures by the Board

C. Small procurement under one thousand dollars

EFFECTIVE DATE: This Law shall become effective immediately upon filing of same in the Office of the Secretary of State after being approved by the qualified voter.

Town of Shandaken Request for Proposals

Project Description and Preliminary Scope of Work

The Town of Shandaken is soliciting proposals from qualified engineering firms for assistance in the following:

Project Description

Create construction design plans and estimate costs to construct the recommended municipal drinking water system improvement to complete the "High Street Loop" for the Phoenicia Water District in the Hamlet of Phoenicia NY.

Completion Date

The required completion date of this project is September 21, 2012.

Scope of Work

Professional services required are likely to include:

Survey work including land elevations

Detailed Construction plans illustrating depths, lengths of run and materials needed

Detailed estimate of costs for both materials and construction

Other: The successful firm must comply with all applicable funder requirements.

Submittal Content

The proposal must be organized in sections containing the following information:

Description of Firm. Describe your firm's legal structure, areas of expertise, length of time in business, number of employees, and other information that would help to characterize the firm. Provide the address of the main office (for legal purposes) and the address of the office that will manage the project.

Experience. Briefly describe other projects executed by your firm that demonstrate relevant experience; however, extensive descriptions of vaguely related projects are discouraged. Also list all public sector clients for whom you have performed similar work in the past five years. For each project mentioned, include the name, address and phone number of a person who can be contacted regarding your performance on the project. When submitting projects for which your firm worked in an auxiliary capacity or in a joint venture or partnership, include the name and address of the lead firm as well as the name and addresses of the other firms with which you worked.

Personnel. Provide a professional resume for the key people proposed to be assigned to the project (including any important sub-consultants), and describe relevant related experience. Describe key personnel's proposed roles and responsibilities on this project. Submittals must identify a proposed project manager, who would be responsible for the day-to-day management of project tasks and would be the primary point of contact with your firm. An organization chart of the project team may be appropriate but not required.

Project Approach. Describe the tasks that must be accomplished to complete the project. Provide a narrative description of how the firm proposes to execute the tasks. If applicable, discuss any unique aspects of the project, alternate approaches the Town of Shandaken might wish to consider, or special considerations related to programmatic/ funding requirements. Your firm should rely on its expertise and experience with similar projects to demonstrate how it will effectively complete the project.

Project Schedule. Provide a schedule of general project activities indicating the duration of each activity and of the total project, including a schedule of Personnel to be assigned to project. The schedule should reflect realistic activity durations.

Brochures or other material that may be helpful in evaluating your firm may be included in an appendix of the proposal.
