Recreation – Martie Gailes – our next Rec. Board meeting is 3pm on Tuesday Aug. 16th at Town Hall.



Upcoming Town Board Topics & Activity

Month of August 2016

PURCHASES AND REPAIRS: Tonight we have a few resolutions concerning purchases and contracts for multiple departments throughout the Town. The Highway Department is looking to replace an outdated chipper. They will be placing the old one out for auction and purchasing a newer chipper from a public bid site. The Parks and Recreation Board earlier this year was awarded a grant through the O'Connor Foundation, part of that award was for the purchase of two Soccer Goals for Smith Park in Pine Hill. There are more purchase to come from that grant over the next few months. The Museum is in need of a storage shed and have received three bids for the shed. They are recommending the purchase of the shed from Farmer Jones Baby Barns here in Shandaken and we will be looking to use some of our Good Neighbor funds for this purchase. Lastly, last month we went out for bids for necessary repair work for the Town Owned building in Phoenicia. We will open the bids tonight and, considering the bid amounts, may be looking to utilize Good

AMBULANCE: Following last month's resignation of Ambulance Chief Muellerleile, Brendan Whalen has been appointed Interim Chief. Mr. Whalen was the Training Officer for the Department and following his appointment as Chief he has resigned from his Training Officer position and has made a recommendation to appoint Paramedic Michael Williams as the Training Officer for the remainder of the year.

Neighbor Funds to complete these repairs to the roof and basement entry.

EVENTS: We have several events this month as we wind down the summer toward Labor Day. This week is one of our biggest events with the 7th Annual Phoenicia International Festival of the Voice, this year's event will highlight the works of William Shakespeare and other British and Celtic works. The event will culminate with a performance of Othello on Saturday night. If opera is "not your bag, man" take a look at the schedule as I'm sure you'll find something that may peak your interest. We wish them a wonderful event, with delightful weather and robust audiences.

Of course, not to be outdone is our own Town event, Shandaken Day, due to take place on Saturday, August 27th from 10am until 6pm at Big Indian Park on Route 28. This year we have received corporate sponsorships from three of our local banks (Community Bank in Boiceville, and Key Bank and Ulster Savings Bank in Phoenicia). They have provided us funding to hold the First Annual

Shandaken Human Foosball Tournament. Just like the tabletop game, but on a much larger scale, we are looking for eight teams of six people who will represent a local not-for-profit organization (library, fire department, arts organization, etc.). Team members do not have to be members of the organization. The teams will battle through 10-15 minute games in a single elimination tournament. There will be cash prizes upwards of \$250 provided to the top four teams for their respective organization. We hope this adds a bit more fun to the festivities along with the usual kids' games, vendors, food and Live Music all day from Wyld Blue. Additionally, the Shandaken Day Committee has selected the following individuals for recognition this year: The Hamlet Heroes for Chichester, Phoenicia and Woodland Valley will be Michael Ricciardella and Calvin Smith; the Pride of Shandaken Award this year will go to Teresa Grant of Shandaken. Each of these individuals has helped shape what makes our Town a unique place to live and have, through their individual and prolonged efforts, improved the quality of life in our Town for residents and visitors alike. We look forward to bestowing these awards at Shandaken Day and hope to see you all there on Saturday, August 27th. There are only a few vendor spots left, so if you were looking to secure your spot please download the form from the Town website or by calling the Town Clerk's Office at 688-5004.

LIBRARY: We have representatives from the Phoenicia Library here to discuss their proposal to increase their current funding through property taxes. They are proposing an increase of \$68,000 to go from a \$94,000 annual tax levy to \$162,000. The increase represents a 72.3% tax levy increase. The libraries in our Town are not funded through a Special District, they both (Phoenicia and Pine Hill) receive their monies through the levy imposed by the Town of Shandaken. We collect the tax on their behalf and disburse it to them early on in the year.

The libraries though are what are deemed Association Libraries, whereby each has their own governing Board of Directors. The Board of Directors votes as to how much funding to request each year. If they wish to increase their funding, the Board of Directors votes to do so and then must complete a petition signed by Town voters in order to force a public referendum vote to the voters for said increase. By course of action the Town Board cannot, once the petition is Certified by the Town Clerk, deny the petition and must accept it and request the Board of Elections to place it on the ballot for the next general election (this November).

This tax increase, with the Phoenicia Library being the sole beneficiary (Pine Hill Library is keeping with their current funding at \$24,000 annually), without any other increase to the General Budget would read as a 3.88% increase on the General Town tax line of your Tax Bill in January. In essence, if you paid \$1,000 in General Town taxes last year you would pay \$1,038.80. That is before we add any increases for Healthcare and Retirement costs for Town Employees, Departmental needs, Highway Equipment, etc. We have confirmed that the Library Budget would not affect our Tax Cap calculation and as we have proven in the past we will work hard to keep your taxes within the Cap as best we can. Meaning, we strive annually to not impose a tax increase of more than \$20 on the \$1000 levied the previous year.

Our next regular meeting is scheduled for Monday, Sept. 12, 2016 at 7:00 pm.
