MINUTES FOR REGULAR MONTHLY MEETING
October 10, 2018

Public Hearing:

Mary Garraffa – Special permit – “Windy Ridge” Pre-school – 1446 Wittenberg Rd.

Motion to open the public hearing made by Board Member Rabuffo, seconded by Board Member Christie. All in favor. Mrs. Garraffa is applying for a special permit to operate “Windy Ridge” pre-school out of her residence located at 1446 Wittenberg Rd. Chair Brewer finalized the site plan for this project, therefore being recused. A letter was submitted by Mr. Warren Adler, abutting neighbor across the street that was read aloud by the Planning Board secretary, his main concerns were the hours of operation not ending when suggested, noise from the children playing outside, and the increase of traffic with the ingress and egress of pick up and drop off in the morning and afternoon. Mrs. Garraffa stated that the hours were 9-5, but sometimes parents can run a little late and some of the kids could potentially be there later than that. There were a few people present on behalf of the Garraffa’s, also neighbors, that are happy to hear kids playing outside and have no objections to the special permit being granted and the pre-school continuing to operate where it is. One concern was that the speed limit should be reduced on Wittenberg Rd. but this would need to be brought up to the County, as Wittenberg Rd. is maintained by the them. Board members stated that they would put in a request for this. The County was also informed of this application because it’s within 500 ft. of a County Rd., and determined that there was “no county impact.” A suggestion was also made to add more “children playing” or “slow” signs be erected to indicate where travelers should slow down. With no further inquiries from the audience or Board, a motion was made by Board Member Kalb to close the public hearing, seconded by Board Member Christie. All in favor.

The regular meeting was called to order by Chair Brewer at 7:00 pm with the pledge of allegiance.

New Business:

Evan Yurman – 171 Mtn. Laurel Rd. – Special permit for FFL:

Mr. Yurman is applying for a special use permit for a Class II Home occupation to alter firearms in the basement level of an accessory structure currently being used as a garage/storage. The business is internet-based, no employees, and will have no increase in traffic, signage, or construction on property. The driveway is sufficiently long, gated, and has a security system already in place. The FFL application seeks ATF approval for Type 1 (“dealer”) and Type 7 (“manufacturing”). ATF defines manufacturing as any customization/alteration of firearms, commonly known as gunsmithing. The activities to take place on-site will be more closely related to activities of an artisan or craftsperson. Mr. Yurman will also be very strictly regulated by the ATF and subject to any inspections they feel are necessary. Chair Brewer went over Part 2 of the Short Environmental Assessment Form (SEAF), with all questions resulting in “No, or small impact to occur.” Motion was then made by Board Member Kalb for a negative declaration, seconded by Board Member Rabuffo. All in favor. With no further questions from the Board, a motion was made by Board Member Kalb to send the application to public hearing for next month, seconded by Board Member Rabuffo. Public hearing scheduled for Wednesday, November 14th at 6:45 PM.


