Motion was made by Board Member Rabuffo to accept the January 18' minutes as written, seconded by Board Member Christie. All in favor.

Old Business:

Crossroads – Belleayre Resort:

Crossroads has submitted a letter to the Planning Board requesting another 6 month extension on the signing and stamping of their final site plans, AND the renewal of their special permit. Due to the pending litigation with the CHA, they're currently not in the position to submit yet. They have oral

arguments in front of the Appellate Court in Albany on March 29th which will be the last time in front of the judges; ruling will take 6-8 weeks. Mr. Olson is representing the Shandaken Planning Board for this matter. The special permit is set to expire on March 16th, pursuant to the regulations set forth in the Town of Shandaken Code, the permit shall become invalid if the permitted use is not commenced or a building permit is issued within one year of the approval date. Since neither has happened, they can ask the Board to renew the permit for another year. The Board didn't have any further questions on the matter. A motion was made by Board Member Christie to extend the signing/stamping of final site plans for 6 months, and renewal of the special permit, seconded by Board Member Kalb.

Big Indian Adventure Park:


The ropes course is still in the survey process due to the amount of snow still covering the ground. No application has been received yet.
