Minutes:

Board reviewed July meeting minutes, (no meeting since then) and a motion was made to accept minutes as written by Chair Johnson, seconded by Board Member Reiss. All in favor.

Use Variance - Steve Linnekin - 8ft. Sign

Mr. Linnekin would like to put up an 8ft. sign on his property located at 5295 Route 28 to advertise his leather business. It's mostly conducted in the winter months as they travel to fairs in the spring/summer. Presented as a Use variance for the location, he'd like to set it closer to the road than allowed by the Code. Also, it can't be within the DOT right of way, which is usually 60 ft. from the center line of the road. Usually the power lines that run across the property indicate where the DOT's right of way is, the sign is set back farther than that. In applying for a Use variance, the applicant must present the Board with proof of financial hardship, that it's not self-created, that it's a unique hardship that doesn't apply to another portion of the neighborhood, and that it won't alter the essential character of the neighborhood. It was clarified that the use in question is for the sign only and not for the conduction of the business. Board discussed the possibility of switching to an area variance for the setback issue of being closer to the road than permitted. Total size will be 15 square feet, 24 is the allowable square footage. Motion was made by Board Member Reiss to send the application to next month's meeting as an area variance, seconded by Chair Johnson. All in favor.

Adjournment:

There being nothing further before the Board, a motion was made by Board Member Reiss to adjourn, seconded by Board Member Guglielmetti. All in favor. The Zoning Board of Appeals meeting adjourned at approximately 8:05 PM.
