Motion was made by Chair Johnson to accept the minutes as written, seconded by Board Member Reiss. All in favor.

Old Business:

Keith Marlin & Jess McNear – 85 Bonnie View Ave. – Wellness Center & retreat:

Jess McNear present again to present her application for a use variance to run a wellness center and retreat, with four (4) rooms available to transients, at 85 Bonnie View Ave. Last month they provided the Board with a large packet of information regarding their project and the parcel itself. The Board asked them to return this month in order for the Board members to review the packets and possibly do a site visit. The Board is trying to decide on what category to place this application under. Majority of them think it falls under "hotel" with the amenities being accessory structures to the hotel. Board Member Reiss requested that the current owners, Crossroad Ventures, LLC, sign an authorization form indicating Keith & Jess as their representatives since they don't own the property yet. Variances can't be issued to anyone other than the property owner. They currently have an offer in on the property. They've been meeting with architects and engineers to discuss the extent of the work needed to bring the building into compliance. Ms. McNear stated that the foundation was still in good condition but everything inside needs to be stripped and redone. In the end, the Board agreed that she should return to the Planning Board and apply for a special use permit to operate a hotel.


Other Business:
