Shandaken Historical Museum Monthly Report for June 2024

In early June the Museum board prepared for upcoming summer events. On Saturday June 8th, the Phoenicia Elementary School held their closing celebration - the Phoenicia Farewell Fair, which included a large photo montage presented by the Museum to celebrate the sixty-year history of the school made from yearbook images and various highlights of attending the Phoenicia Elementary School. After the fair, a number of items from the school archives were donated to the Museum's collection.

Also on June 8th, the Museum participated in the Great Outdoors Expo held at the Catskills Visitor Center in Mount Tremper. The Museum table at the Expo had hundreds of visitors with their families, many bought books, gave donations and played a Shandaken trivia game.

We are currently planning to take part in some of the Farmer's Markets in Phoenicia using our traveling Museum table to better establish an active presence in the community.

The museum is continuing with its reorganization and inventory projects along with adding new exhibits to the Museum.

On June 14th, the Museum hosted a drum circle event led by noted author Evan Pritchard along with members from the Big Indian Native American Cultural Center who joined in with lively drumming and singing. It was attended by over a dozen participants.

There were 32 visitors in June visiting the Museum from the west coast, New York City, New Jersey, Europe and Australia - many leaving donations and grateful messages as they signed the registry.


