Please check in on your elderly neighbors in the heat of summer- as some compensate for heat poorly due to existing medical problems, poor circulation, dehydration, and regular medications.

Also, pay particular attention to the signs and symptoms of heat exhaustion and heat stroke in all ages while enjoying activities outdoors. We all think we can “take the heat”, but in reality we all walk around dehydrated already, and tend to ignore symptoms of these ailments even when they are present. Please refer to the below signs and symptoms, exercise caution in the heat, and drink plenty of water!!!! As always, call 911 in an emergency.

Heat Stroke (A DIRE MEDICAL EMERGENCY):

- Body temperature over 105 degrees
 - Throbbing headache
- Dizziness and light-headedness
- Lack of sweating despite the heat
 - Red, hot, and dry skin
 - Muscle weakness or cramps
 - Nausea and vomiting
- Rapid heartbeat, which may be either strong or weak
 - Rapid, shallow breathing

- Behavioral changes such as confusion, disorientation, or staggering
 - Seizures
 - Unconsciousness

Heat Exhaustion:

- Confusion
- Dark-colored urine (a sign of dehydration)
 - Dizziness
 - Fainting
 - Fatigue
 - Headache
- Muscle or abdominal cramps
- Nausea, vomiting, or diarrhea
 - Pale skin
 - Profuse sweating
 - Rapid heartbeat

**RESOLUTION IN THE MATTER OF THE ACQUISITION OF
CERTAIN FEE ACQUISITIONS FOR USE IN PUBLIC PROJECT**

WHEREAS, as part of the Watershed Protection and Partnership Programs of the New York City Watershed Memorandum of Agreement (“MOA”), New York City provided funding for the New Sewage Treatment Infrastructure Facilities Program (NIP) and the Community Wastewater Management Program to assist in the development of new sewage collection and treatment facilities in up to twenty-two (22) selected villages and hamlets in the NYC Watershed;

WHEREAS, the Town of Shandaken, New York (“Town”) was identified in the MOA as one of the twenty-two (22) priority communities to receive funding for the study, planning, design and construction of a sewage collection system and/or the creation of a septic maintenance district in the Hamlet of Shandaken in the Town of Shandaken (the “Project”);

WHEREAS, subject to permissive referendum in the manner provided in Town Law Article 7, a majority of the property owners within the proposed service area of the Project voted in favor of the establishment of the Shandaken Septic Maintenance District;

WHEREAS, a certificate of the Town Clerk was filed pursuant to Town Law § 209-e(4) certifying the results of the special election held on March 30, 2019 stating that a majority of property owners in the proposed septic maintenance district voted in favor of the establishment of the district, and per Town Board Resolution No. 76-19, the Town formed the Shandaken Septic Maintenance District;

WHEREAS, due to failing septic systems and demonstrable water quality problems, a primary purpose of the Project is to construct and maintain an adequate system for sewage removal and treatment to ensure the health, safety and welfare of Town residents and businesses;

WHEREAS, design and construction of the proposed sewer system will be performed in conformance with New York State Department of Environmental Conservation Design Standards for Wastewater Treatment Works, 2014 (2014 NYSDEC Standards), New York State Department of Health Design Standards for Wastewater Treatment System (10 NYCRR Part 75 and Appendix 75-A), and the Rules and Regulations for the Protection from the Contamination, Degradation and Pollution of the New York City Water Supply and its Resources, 2010 (NYCWRR). Regulatory review and approval will be obtained prior to the initiation of construction;

WHEREAS, the Town of Shandaken Town Board (the “Board”) has reviewed and considered the plans and schematics for the Project, as reflected in the Preliminary Engineer’s Report Community Wastewater Management Program For The Hamlet Of Shandaken, Town of Shandaken, Ulster County, New York, dated June 2017, prepared by Lamont Engineers, which requires the Town to acquire certain property in the area of the Septic Maintenance District to accommodate the Project;

WHEREAS, the Town Board has determined that the Project is in the best interest of the Shandaken Septic Maintenance District and its residents and, as a result, that the contemplated acquisitions are in the best interests of the health, safety and welfare of the Shandaken Septic Maintenance District and its residents, as it is in the public’s best interest that the Project be properly constructed and maintained;

WHEREAS, the Board has endeavored and will continue to endeavor to acquire any necessary acquisitions for the Project by voluntary compliance with land owners, but the Board acknowledges that voluntary compliance may not be achieved for all the necessary acquisitions requiring the Board to exercise its powers of Eminent Domain;

WHEREAS, certain remote site locations are necessary for leach fields, and after an exhaustive study prepared by Lamont Engineering, those certain remote site locations are no longer subject to change;

WHEREAS, the value of the remote sites will be based on standard appraisal procedure; and

THEREFORE BE IT RESOLVED that the Town of Shandaken Town Board hereby determines that when voluntary compliance to acquire certain properties in furtherance of the Project is not practicable or would prejudice the Project, the Town and its legal agents are authorized to acquire the lands or interests by use of Eminent Domain;

BE IT FURTHER RESOLVED Town of Shandaken Town Board hereby determines, as reflected by the Project maps for the Project, acquisition of Tax Map 5.13-3-20 and 5.13-3-21 (collectively “Remote Site”) by Eminent Domain is necessary for construction of the Project;

BE IT YET FURTHER RESOLVED, that the Town Board and Attorney for Town are hereby directed to take such actions as are necessary to implement this resolution and acquire the Remote Site.

**AUTHORIZATION FOR ACCESS TO PRIVATE LANDS FOR INVESTIGATION UNDER EMINENT DOMAIN LAW FOR
POTENTIAL TO ACQUIRE PROPERTY FOR THE SHANDAKEN SEPTIC MAINTENANCE DISTRICT PROJECT**

WHEREAS, as reflected in Resolution No. 76-19, the Town of Shandaken is progressing with a public use project consisting of the development of new sewage collection and treatment facilities (the “Project”) as

previously authorized; and

WHEREAS, potential remote sites in the Town of Shandaken have been identified as being necessary for leach fields associated with the Project; and

WHEREAS, two (2) potential remote sites in the Town of Shandaken are located along Ruthenbeck Road, in the Town of Shandaken, Ulster County, New York (Tax Map Parcel Nos. 5.13-3-20 and 5.13-3-21) (collectively referred to herein as “Remote Sites”); and

WHEREAS, the Town Board has attempted communications with the owner of the Remote Sites, but those communications have not been successful as the owner of the Remote Sites has not been responsive; and

WHEREAS, due to the need for further investigation of the Remote Sites, the Town (and its agents) requires access to the Remote Sites; and

WHEREAS, the Town has endeavored and will continue to endeavor to negotiate with land owners to acquire access to and obtain the necessary property rights for the Project by voluntary compliance with the land owners – including relative to the Remote Sites, but the Town Board acknowledges that voluntary compliance may not be achieved for the necessary access to and potential acquisitions and may require the Town to exercise its powers of Eminent Domain, and

WHEREAS, the necessary access to and potential acquisition of the Remote Sites is in the best interests of the health, safety and welfare of the County, as it is in the public's best interest that the Project be properly constructed and maintained, and

WHEREAS, the Town Board had previously complied with the mandates of SEQRA for the Project, and

WHEREAS, pursuant to the terms of SEQRA, the Town Board has determined that its findings and determinations are consistent with the prior Negative Declaration and there are no negative adverse impacts.

THEREFORE BE IT RESOLVED that the Town of Shandaken Town Board hereby determines that access to the Remote Sites for further investigation purposes to acquire potential easements or fee acquisitions in furtherance of the Project is practicable and will not prejudice the Project; and

BE IT FURTHER RESOLVED that the Town of Shandaken Town Board hereby determines that the voluntary compliance to acquire easements or fee acquisitions in furtherance of the Project may not be practicable and would prejudice the Project; and

BE IT YET FURTHER RESOLVED the Town Board and its legal agents are authorized to access the lands or interests for further investigation in accordance with Eminent Domain Law; and

BE IT YET FURTHER RESOLVED the Town Board and its legal agents are authorized to move forward to investigate the necessary lands or interests by use of Eminent Domain; and

BE IT YET FURTHER RESOLVED that the Town Board and Attorney for Town are hereby directed to take such actions as are necessary to implement this resolution.

RESOLUTION TO AUTHORIZE TOWN SUPERVISOR TO ENTER INTO AGREEMENT FOR RE-USE PLAN REGARDING SPECIFIC PROPERTIES TO BE ACQUIRED FOR A PUBLIC PROJECT

WHEREAS, The Town of Shandaken acknowledges the importance of preserving natural conditions to promote erosion control and flood protection at certain properties and will seek to preserve natural vegetation to the extent practical and consistent with the uses described in a *Re-Use Plan* and any flood mitigation plans.

WHEREAS, the PROPERTIES to be acquired are SBL # 25.15-1-46; 25.15-1-47 & 25.15-1-51 located at 5478, 5474 & 5462 NYS Route 212, Mt Tremper, NY 12457 currently owned by Theodore R. & Lynn Byron AND SBL # 25.15-1-49 located at 5468 NYS Route 212, Mount Tremper, New York, 12457 currently owned by Scott and Ann F. Lefferts; and

WHEREAS, the specific purposes for the acquisition of the Properties are to:

- Protect water quality;
- Enable the construction of a large-scale flood mitigation project that will reduce future flood risks and damages to critical transportation infrastructure and local residences and business along the Esopus Creek; and
- Protect and enhance the floodplain of the Esopus Creek so as to further mitigate flooding impacts on nearby properties; and

WHEREAS, the following are options for the future use of these Properties identified by the Town. All uses shall be consistent with the terms of the conservation easement and purposes of the acquisition. Other uses, not listed below, may be allowed under the conservation easement, but prior approval is required by NYSDEC.

1. Open space, nature preserve, riparian buffer consisting of grasses, wildflowers, trees and shrubs
2. Outdoor recreational activities including, but not limited to, general access to the Esopus Creek, fishing access, bird/wildlife watching, etc.
3. Allow for the construction of a flood mitigation project which includes the replacement of the Route 28 bridge over the Esopus Creek and the realignment of State Route 212
4. Operation and maintenance of the flood mitigation project mentioned above
5. Access and parking associated with the above planned uses
6. Installation of educational, informative, or access signage; and

WHEREAS, nothing in this *Re-Use Plan* restricts the rights of NYSDEC or its agents or assigns from entering these Properties to inspect as needed for the purpose of verifying compliance with the conservation easement and this *Re-Use Plan*.

THEREFORE BE IT RESOLVED, the Town Board of Shandaken does hereby authorize the Town Supervisor to enter into agreement regarding the Re-Use Plan for said Properties mentioned above for the purposes of assisting in a public project.
