We will be providing 24-hour security staffing for Mountain Jam 2025 at Belleayre Mountain located in High Mount New York.

GMCS will provide UNARMED security officers working 12-hour security operational shifts while following the direction of the Event Coordinators of The Grass Roots Festival, Director of Security and all law enforcement agencies involved. The Security Supervisors will have direct contact with the Event Coordinators, Emergency Medical Services Personnel, and law enforcement agencies. The Security detail will include a combination of fixed post positions as well as mobile patrol teams.

Primary duties of the Security Company will include, but are not limited to:

- Securing the perimeter of the site and campground by roaming the sites to assure there are no issues with fencing.
- Maintaining all emergency access roads and keep gates clear by roaming and clearing any obstacles or people
- On overseeing camping set up/maintenance of the 5' rule in campsites smaller than 1250 square feet and 10' separation between sites 1250 square feet and larger, by using a stick to measure distances between sites and structures on sites both onsite and Across the Way. In addition, they will oversee flagging off wooded camping areas at Across the Way.
- Preventing unauthorized people from entering restricted areas by monitoring wristbands and other credentials (staff, press, etc)
- Identify and report any instances of violence or illegal activity to law enforcement
- Enforce ban on open flames on anything other than camp stoves on large sites by monitoring campsites and other festival grounds to ensure only camp stoves are used on large sites, there is no other open flame, and confiscating any flammables or other prohibited items from small, and large sites, if applicable
- Enforce ban on any flames in tent camping area and small vehicle camping sites by doing a fire watch throughout camping areas, putting out any fires, and confiscating prohibited items.
- Enforce ban on unauthorized selling of food and other goods by ensuring any sales are in designated areas only
- Assist patrons with event information by being present at all gates and throughout the festival and being available to answer questions or provide any help needed.
- Assist Emergency Medical Services Personnel as needed by clearing people or objects from emergency areas
- Coordinate responsibilities with the promotor and operations staff of Mountain Jam 2025, through email communications and meetings prior to the festival, and through face to face, radio, and phone communication during the festival.
