# SUPERVISOR REPORT

We are gathering information about the possibility of the Phoenicia school takeover and costs associated with its operation, maintenance and imminent future repairs. All this includes a commercial building inspection and environmental assessment. This information is vital to make an informed decision on whether to encumber the Town with this responsibility.

Part of the decision centers around accepting the property for \$1, if the whole district approves a referendum vote, and when that vote can practically take place. Best case scenario is during the district-wide budget vote in late May but it doesn't seem likely because we need so much more information before the March 18 deadline to make that possible. We are working with the County Board of Election to try and schedule it during the November election cycle but that may be too complicated from the 2 of 4 Towns only partially in the Onteora District.

Or, we could decline the School District offer and let the building go for sale on the open market. If we purchase the property on the open market, it will not have to go to a district-wide referendum. The other part of this decision; if we take the \$1. deal and are given the school by referendum, there are State enforced restrictions on what we can do with the extra space.

The school is about 30,000 square feet of space and our current Town Hall is less than a third of that. Even including the auditorium, kitchen and gymnasium for 'community activities' would leave about 10,000 square feet unused. Any and all space could only be used for 'public good' space. Only certain not-for-profits or other governmental entities would be able to rent the space. If we purchased the property on the open market, the Town could rent the extra space to entities we feel would benefit the Town. This revenue could help defray costs associated with operation and maintenance.

More meetings will take place when we have more information to report.

Also tonight, we will be presented with 'Mt. Jam' a music event at Belleayre Mt. in late June. There have been a few meetings with all the agencies involved, mostly Ulster County EMS, Planning and Health Departments and our own Police and Ambulance.

Like buying the elementary school, this is an event the likes we have not previously encountered and we will take very seriously and methodically.

We have had 2 informational and a public hearing on the new water metering system for Pine Hill and will likely vote for the purchase installation and financing of this \$150,000. Dollar improvement for Pine Hill.

Our engineers are waiting for the spring thaw to do exploratory work on the Pine Hill Parking lot to design a storm- water system to help alleviate the drainage issues.

We still do not have any information on Ulster County's determination about the Phoenicia Bridge Street bridge.

#### The Monthly Report for The Shandaken Historical Museum for February 2025

On Sunday, February 2<sup>nd</sup>, the Museum hosted a demonstration of rug hooking by Museum Chairperson, Andrea Singer. It was attended by a half dozen local fabric enthusiasts, each learning how to make beautiful rugs, matts and pieces of art out of yarns, fibers and wool scraps. This is a traditional craft with a rich history where the final piece is often a work-circle collaboration between friends. The presentation was richly rewarding and empowering for all those who attended.

The Museum has been asked by the consultant group Patterns of Progress to write and submit a one-page history of the Town of Shandaken to be included in the next version of the Comprehensive Plan for the Town of Shandaken.

The Museum is currently looking for volunteers to work part-time to assist with museum projects like cataloging the museum inventory. General web skills or an interest in local history is a plus.

On Saturday March 1<sup>st</sup> the Museum hosted a multimedia presentation by Jay Simpson about the early days of skiing in Phoenicia. The presentation was well received with over 35 avid ski fans attending.

We are currently planning for a Native American drumming event led by noted author Evan Pritchard for Friday March 21st<sup>th</sup>.

In February the museum had some 35 visitors of both locals and tourists. Many left generous contributions and grateful messages.

> Phoenicia Water District Committee Report to Town Board March 3, 2025

The Committee met in February 4, with Board member Drake in attendance.

We recommended a specific candidate for hire the position of Deputy Superintendent for the Phoenicia Water District.

Barbara Mansfield spoke with Teddy Byron about broken hydrants mentioned the in public meetings for the Comprehensive Master Plan. He said there were two: one at the very end of Phoenicia on 214, and the last one on Plank Road. He also said that there is not enough water pressure from hydrant on Ave Maria to put out a substantial fire in that complex.

Our understanding is that, at the suggestion of Barbara Twerdak, key pads were ordered, and that the codes would be on file in the Supervisor's office.

The Committee is hoping the Superintendent and Deputy Superintendent can will complete a Standard Operating Procedure (SOP), an Emergency Response Plan (ERP), and a Vulnerability Assessment (VA) as soon as they are able. The Committee also recommends that Superintendent and Deputy Superintendent research and then determine what facilities in Phoenicia are required to have testable backflow devices.

In order to pay for the desperately-needed third pump for the Phoenicia Water District, it is out understanding that a significant grant will be needed, and that the cost will exceed th \$200,000 limit of the National Rural Water Loan Fund.

It is our understanding that the County will finish the loop when they do bridge work, tentatively slated for 2026.

We recommend a water tower inspection.

#### Parks & Recreation Committee March Report

The Committee's understanding is that of the 2025 budget line of \$30,000: \$20,000 of that is allocated as a match for CREST funding, \$5,000 is for the summer recreation program, and \$5,000 for various Parks projects. The Committee has \$2,899 in a designated Ulster Savings account, \$9,874 in the Turkey Trot funds for Parks; and about \$2,000 in Dog Park fund. Autumn submitted a \$5,000 bill to the Supervisor's office from KaN for playground plans to be taken from Turkey Trot funds.

Trash: The Committee has brought up the need for trash receptacles in our parks. Board member VanBlarcum explained to the Committee the Town is not staffed for trash removal. The Committee will work on better "carry in, carry out" signage in the meantime.

The Committee is seeking a donation of a concrete culvert pipe for the Glenbrook playground.

Glenbrook Park has 21 seating options + 2 tables for naming opportunities. Email <u>shandakenparksproject@gmai.com</u> if interested.

The Committee is seeking a designated volunteer for Glenbrook Dog Park. Please email <u>shandakenparksproject@gmail.com</u> if interested.

The Committee recommended at metal roof for the pavilion. Hommel has submitted a revised quote, but an estimated total for the Glenbrook pavilion of about \$124,000 is within the DEC Smart Growth grant. We are hoping the Board will meet soon regarding a resolution to amend the original quote.

DASNY has requested a SEQRA (environmental review)—a type 2 that can be completed by the Board. Our hope is that you will do that at the same special meeting this month.

Love Your Park Day is Saturday, May 3, with a rain date of Sunday, May 4. We request volunteers for our first annual event show up at Parish Field at 10:00 a.m. Phoenicia Farm Market opens May 18<sup>th</sup> and runs through Oct 26 in Parish Field. The Phoenicia Festival of the Arts is Thursday, August 28<sup>th</sup> through September 1<sup>st</sup> at Parish Field. The Committee has an ambitious goal of having 9 mini golf modules in the Park by then.

Kerry Henderson reported that he is working on a shovel ready plan for the Skate Park. Kevin is checking to see if the footprint of the existing blacktop is okay to be the footprint for skate park. Kerry needs to get a survey done for the plan and has already received a generous quote from Don Brewer to be covered by Skate Park funds..

Autumn brought up the need for the flag to be raised. It is still lowered in memory of Jimmy Carter.

#### Dynamic Water Concepts to Install Mesh Read Water Meters in the Pine Hill Water District

**WHEREAS**, the water meters in the Pine Hill Water District were installed over twenty years ago and the radio transponders are no longer functional, and

**WHEREAS** the lack of reliable cellular service across the Pine Hill Water District prevents the effective use of cellular water meters, and

**WHEREAS** real time monitoring for potential leaks is a requirement for the healthy, safe, and effective management of the water district, and

**WHEREAS** no company that serves our region besides dynAMIc Water Concepts has been identified as providing a system that uses mesh meter-to-meter communication, AND no alternative systems or types of systems have been identified that meet the above requirements,

**BE IT RESOLVED**, that the Shandaken Town Board declares dynAMIc Water Concepts to be a sole source provider of this type of system,

**AND FURTHER RESOLVED**, that the Shandaken Town Board shall seek a 10-year loan for \$112,764.00 from the Rural Water Loan fund to fund this project,

**AND FURTHER RESOLVED**, that contingent upon the successful receipt of that loan, the Shandaken Town Board shall contract with DynAMIc Water Concepts at a one-time cost of \$150,351.52 and an ongoing annual cost of \$3,813.00 for the installation of new water meters for the Pine Hill Water District including associated software and training.
