Resolution Setting Film Permit Fee Structure

WHEREAS The Town of Shandaken passed Local law #1 of 2026 entitled “Film Permitting” established a firm permit process within the town and,

WHEREAS § 43-5. of said law specifies that applicants shall pay an appropriate fee as determined by the Town Board, but not to exceed \$5,000.

THEREFORE BE IT RESOLVED, the fee for film permitting shall be \$250 per day for each location filmed at during that day, unless the cost would be greater than \$5,000 in which case the fee shall be \$5,000. This fee does not include any incidental costs as described in LL #1 of 2006 § 43-6

THEREFORE BE IT FURTHER RESOLVED, as indicated in § 43-5, this fee may be waived by a resolution of the town board when filming is done for charitable, education, public service, or other similar non profit purposes.
